Regulations of the D.A.V. College Trust and Management Society

(Registered under the Societies' Registration Act, 1926)

Aims and Objects

1. A Society for establishing and managing in Punjab and elsewhere institutions (a) to commemorate the memory of Bhai Dayanand Saraswati and (b) to propagate the teachings of the Vedas, is constituted and registered under the Societies' Registration Act XXI of 1860.

2. The said Society is designated "The Dayanand Anglo-Vedico College Trust & Management Society." The Registered Office of the Society shall be at New Delhi.

3. The objects of the Society are :-

(a) To establish in Punjab and elsewhere institutions such as colleges, schools, boarding houses, ashrams, etc. with the following purpose :-

(i) To encourage, improve and enforce the study of Hindi;

(ii) To encourage and enforce the study of classical Sanskrit and the Vedas;

(iii) To encourage the theory and practice of Ayurveda and

College Trust & Management Society, if he is otherwise satisfied, may accept such person's declaration in writing that he is a member of the Arya Samaj.

3. The Society shall comprise all those persons who have donated Rs. 250/- or more in one lump sum to its funds of a permanent nature and are members of any Arya Samaj affiliated to the Arya Prudeshik Pratimadhi Sabha, but subject to the approval of the President, D.A.V. College Managing Committee, New Delhi, provided that the Society may waive the condition of affiliation with the A.P.P. Sabha in case of any specified Arya Samaj or Arya Samajee.

4. Every member of the Dayanand Anglo-Vedic College Trust & Management Society shall pay at least Rs. 12/- as yearly subscription or Rs. 100/- for life.

5. No member of the Society shall be entitled to vote at a meeting of the Society unless he has paid monthly subscription, at the rate specified in Regulation 4 for the twelve months preceding the date of the meeting or since the date of his membership, whichever is less, and his name shown in the register of members prepared for the year under Regulation 5D (A/17).

6. Subject to the control of the Dayanand Anglo-Vedic College Trust & Management Society and to such Regulations as have been passed by or may from time to time be passed by the said Society, the affairs of Society shall be conducted in its objects carried out and the institution under its control managed by a Managing Committee which shall be composed of

- (a) Members returned from the Arya Samaj in accordance with the provisions of Regulation 3 (a) and 8 (a)(ii).
