- 2) Buses must adhere with Government's norms laid down by the State Transport Department and Vehicle. The buses must always carry the following valid updated documents (in original) on the road and the same be produced on demand by the officer empowered to demand these documents to verify, under the Motor Vehicle Act 1988 along with other documents as displayed in E - parivahan portal whenever required:
- a) Certificate of Registration.
- b) Certificate of Fitness.
- c) Certificate of Insurance.
- d) Taxation Certificate (Tax Token)
- e) Driving License with badge.
- f) Permit granted by the Regional Transport Authority.
- g) Pollution under control certificate up-to-date papers.
- 3) Hire charges will be paid to Party/Bus owners through Account Payee M. C. Cheque/RTGS only after deducting TDS as per Income-tax rule, Govt. of India.
- 4) Party/Bus owners will be responsible to deduct PF and ESIC contribution and also be liable to police & road accident litigation and any other legal issues etc.
- 5) Diesel will be provided by the school management/by the contract party as per the running average mentioned in the agreement.
